We would be grateful if you could provide us with the following information under the Freedom of Information Act, relating to the codes used in your hospital to document this condition and its treatment:

Coding relating to diagnosis:

- Patellar dislocation \$83.0 acute/M22.0 chronic
- Recurrent patella dislocation M22.0
- Patellar instability M22.3

Coding relating to treatment:

- Lateral release W78.3 or may be dependent on what is being released refer to individual operation note
- **Trochleoplasty -** No dedicated code. This is coded dependant on the documentation in the operation note.
- Tibial tubercle osteotomy W77.5
- Medial patello-femoral ligament (MPFL) reconstruction W74.3 Z84.4/Z84.6 or O27.1 Z84.4/Z84.6 if stabilisation of the joint
- Proximal realignment Code dependant on what is being released
- Allograft (at the time of MPFL reconstruction) W74.3 Y27.2 Z84.4/Z84.6 or W74.3 Y27.2 Z84.4/Z84.6 if stabilisation of Joint
