INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

You asked:

Please can I make an FOI Request for the following information:

1. What First Aid Training and Mental Health Training, if any, do you provide to your staff?

The Trust delivers the 3-day first aid training and the 1-day emergency first aid at work training.

Mental Health Responder training for staff was piloted at WWL in 2019. The 1 day training provides attendees with an understanding of poor mental health, such as signs, symptoms and associated stigma – along with the knowledge and skills to have the confidence to support somebody displaying poor mental health and signpost to appropriate help; either at WWL or in the community.

2. The current provider of First Aid Training and Mental Health Training to your staff and contract expiry date

Current provider of first aid training is the British Red Cross. Contract expires in 2-years.

The initial pilot was for People Plus to deliver 5 cohorts of training which has been fulfilled and the impact now being evaluated.

3. The name and contact details of the person responsible at your organisation for First Aid Training and Mental Health Training

First Aid training is arranged and co-ordinated by the Health and Safety Team.

Mental Health Responder training is coordinated by Staff Engagement & Development Team under Steps 4 Wellness, Zoe Garnett.
