INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

You asked:

I have a Freedom of Information request. Could you please answer the questions below?

1. In your Trust how many patients have been treated with the following Somatostatin Analogues in the latest 12-month period for which data are available?

- **Octreotide** - 16 patient specific issues in the last 12 months* (note that some stock issues were also made but pharmacy would not hold data for the patients that these were then given to at ward/clinic level)
- **Lanreotide** – 2 patients
- **Pasireotide** - 0 patients

2. In the latest 12-month period how many Acromegaly patients have been treated with the following drugs? Unable to answer, we do not keep indication data in pharmacy, but all issues were checked:

- **Sandostatin LAR** – 0 patients
- **Octreotide Long-Acting (Generic)** - 1 patient received this in last 12 months but indication isn't stated
- **Somatuline Autogel** – 0 patients
- **Pasireotide** – 0 patients
- **Pegvisomant** – 0 patients

3. How many patients have received a somatropin treatment for growth hormone deficiency in the latest 12-month period? Unable to answer, we do not keep indication data in pharmacy but all issues were checked:

- **Genotropin** – 0 patients

- **Humatrope** - 0 patients
- **Norditropin** - 0 patients
- **Nutropin** - 0 patients
- **Omnitrope** - 0 patients
- **Saizen** - 0 patients
- **Zomacton** - 0 patients
