1053 staff accessed the portal to the end of October 2018. There have been 202 applications, 64% of which were approved. We don't hold central records regarding the staff groups accessing the service.

The Trust doesn't offer financial wellbeing advice but does signpost to other organisations as appropriate. Similarly, if a member of staff goes through the process of applying for a salary finance loan but is unsuccessful, Salary Finance will offer financial advice.
