- How many days in total were taken off due to mental health reasons in 2008?

- Please could I also request a breakdown of what categories comes under 'mental health' - eg stress etc.

Please see the information below. Please note that there is no absence reason available that is recorded as "mental health". This is recorded as "Anxiety/stress/depression/other psychiatric". Also please note that where an individual has had more than one absence during each period they are only recorded once in each period
