- *Contract start date, end date and review date of Allied Lifts, RSM, K&S*

The current Allied Lift contract has been extended for a further 12 months – start date 31.08.2017 - new end / review date of 31.08.18

A 2 year contract with the option to extend for refrigeration / ventilation is currently under review – meaning the earliest opportunity for the suppliers to rebid would be 1st July 2019.

WWL currently have 34 lifts (including passenger lifts, goods lifts and DDA access hoists)
