Registered Nursing and Midwifery headcount – 1318 Medical and Dental headcount - 408

2. How many (headcount) nurses took (any number of) sick days between: April 2016 to April 2017? **Eg: 550 nurses** 

Registered Nursing and Midwifery staff - 858

3. How many (headcount) doctors took (any number of) sick days between: April 2016 to April 2017? **Eg: 550 doctors** 

Medical and Dental staff - 132

4. How many (headcount) nurses who took sick leave during these time periods identified 'anxiety, stress, depression' (ASD) or other psychological condition? **Eg: 329 nurses.** 

Registered Nursing and Midwifery Staff - 115

5. How many (headcount) doctors who took sick leave during these time periods

Identified 'anxiety, stress, depression' (ASD) or other psychological condition? Eg: 34 doctors.
