Information Sharing Gateway Project, the Trust seconded in a band 5 for 6 months to undertake information mapping which costed £10,399 which will assist with the compliance with GDPR.

The Trust has recently approved a business case in regards to GDPR. The Trust expects to appoint 2 permanent members of staff who will be working with the existing IG Team on gaining compliance against GDPR requirements.
