INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

We are now pleased to respond to your request for information under the FOI Act.

I would like to formally request some information with regard to sickness absence trigger points for employees who are protected under the Equality Act 2010 and also the Public Sector Equality Duty. I believe that Wrightington, Wigan and Leigh NHS Foundation Trust have an obligation to publish information regarding how these policies are applied to their employees. I have looked for this, but I can't find it and that is why I am writing to you.

Could you please let me know the trust policy with regard to compliance with the Equality Act 2010 and the Public Sector Equality Duty?

The Trust has an Attendance Management Policy that is applicable to all employees of the Trust. The sickness absence trigger levels are outlined in the attached policy and there is also information concerning reasonable adjustments (see section 11) if an employee has a disability that may come under the scope of the Equality Act 2010. The Policy also has an equality impact assessment which reviews any potential impact against the protected characteristics as defined in the Equality Act 2010.

The Trust has an Inclusion & Diversity section on the Trust's Internet site and this holds a wide range of Trust Inclusion & Diversity information which includes (but is not limited to) information on the Public Sector Equality Duty, Equality Delivery Scheme (EDS) and Inclusion & Diversity monitoring reports.
