We are now pleased to respond to your request for information under the FOI Act.

You asked:

How much money has the trust made from car parking charges each year for the last three financial years:

2015-16	£1,077,351.20
2014-15	£998,485.95
2013-14	£1,157,892.98

How much money has the trust made from car parking fines each year for the last three financial years:

2015-16	£7,408.23
2014-15	£11,632.81
2013-14	£11,054.44

If the trust uses an external parking firm to enforce fees and fines, can you tell me what percentage of money made goes to the third party firm, as well as the firm's name.

Revenue 'surplus' remaining after costs incurred through management of PCN's and enforcement (costs due to DVLA checks, letters to owners, etc.) is split 50/50 with Legion Parking services who administer this process for and on behalf of WWL NHS FT through the Security & Car Parks contract with OCS.
