INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

You asked:

I would like to request information under the Freedom of Information Act. Please could you provide the following information:

1) What support do you offer for the family members of patients being treated for cancer within your NHS Trust? (Support can include anything that would contribute to the emotional well-being of an individual, such as support groups, counselling, or advice).

To support family members patients diagnosed with cancer have access to a Clinical Nurse Specialist (CNS) and some tumour sites have access to a Macmillan Support Worker. Most support now is done via telephone rather than face to face due to Covid.

Prior to Covid most tumour sites ran tumour specific support groups which were attended by the CNS, support worker and Information Assistant from the Macmillan Information & Support Service. Family members and friends are encouraged to attend.

The Macmillan Information and Support Service is available to offer emotional support, practical advice and benefit advice to patients and their families. This is again generally offered currently via telephone and some face to face appointments rather than the drop-in service previously available prior to Covid.

The service also ran a 'Walk & Talk' support group for patients and their families and 'Feel More Like You' sessions for patients undergoing chemotherapy prior to Covid. The Information Centres are operational within the Thomas Linacre Centre, The Christie at Wigan RAEI, with outreach services currently on hold which were previously held at Leigh Infirmary, Wrightington Hospital and Community venues.

2) Does your NHS Trust provide any tailored support specifically for young people (under 25s) who have family members being treated for cancer?

We do not have services specifically for under 25's however we are able to signpost to Wigan and Leigh Carers centre who operate a 'Young Carers' service and Maggie's centre who offer a 'Friends and Family' support group.

3) If so, please could you provide details.

4) Are services actively offered to patients' family members, or do they have to approach the Trust themselves to request support?

These services will be generally be offered at diagnosis or following an Holistic Needs Assessment but can be accessed at any time during the pathway and living with and beyond cancer
