You asked:

This is a request for information under the Freedom of Information Act 2000.

### I would like the following information in a digital format:

1. The number of eye examinations held in the years 2019, 2020, and 2021, broken down quarterly if possible.

Please find attached the number of eye examination, broken down quarterly as requested.

2. The number of diagnoses of wet and dry macular degeneration, brain tumour(s), and openangle, angle-closure, and secondary glaucoma which might have been detected by an eye examination in the years 2019, 2020, and 2021, broken down quarterly if possible.

Please find attached the numbers of patient's diagnosed with the conditions requested, however, please note that the Trust does not code such conditions in a manner that enables the identification of the source of diagnosis i.e., detected by eye examination. Moreover, please also note that this data does not include any diagnoses recorded against Outpatient Attendances.

3. The number of people diagnosed with sight loss, or partial sight loss, or other visual impairment, for the years 2019, 2020, and 2021.

Please find attached the numbers of patient's diagnosed with the conditions requested, however, please also note that this data does not include any diagnoses recorded against Outpatient Attendances.

4. An estimate of the number of people whose conditions above have become significantly worse because of the lower rates of eye exams during Covid.

The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

# 5. Where this information is held, I would like the above information to be broken down by age range, ethnicity, and gender.

Please see information broken down by ethnicity and gender above. Unfortunately, we are unable to provide age ranges, as requested, due to the manner in which this data is recorded.
