INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

You asked:

1) Please tell me how many times your Trust has logged an incident of racist/xenophobic behaviour from patients towards staff in 2020.

- 2) For the five most recent cases, please tell me:
- a) the job title of the member of staff against whom the behaviour was levelled
 - 1. Consultant
 - 2. Unknown
 - 3. Agency Nurse
 - 4. Clerical Officer
- b) a brief summary of the content of the complaint (e.g., patient told black doctor to 'go back to where he came from', raised voice, and used profanities)
 - 1. Offensive language used by a patient to refer to staff member.
 - 2. Relative called a member of staff by a derogatory word linked to sexual orientation.
 - 3. Member of staff told by a patient who lacked capacity, that they should not be in our country.
 - 4. Member of staff referred to in a racist derogatory manner.
- c) the action taken by the Trust.

- 1. Security involved, and staff member advised on how to report matter to the Police and staff member actioned this. Patient care transferred.
- 2. Welfare check done with staff and support offered. Staff member advised on how to report to Police but has not yet taken this action. Staff Member no longer sees the patient.
- 3. Agency Nurse didn't want to take matter further.
- 4. Investigated and the person responsible for the offensive language received a first written warning on file for 12 months.
