We are now pleased to respond to your request for information under the Freedom of Information Act.

You asked:

Please can you help me with my study by providing me with the following information?

- *The estimated total annual spend on electrical materials for estates and facilities. E.g Lamps, HVAC, cable, batteries etc*

The annual spend is in the region of £53K

- *Provide the top 10 lines used for example lamps, cable, batteries etc*

Lamps, cables, batteries, electrical accessories, small sized electrical appliances, medium sized electrical appliances, cable containment systems.

Protective devices, miscellaneous fixing items( screws / nuts / rods), electrical hand tools and electrical instrumentation.

- *Detail any potential energy efficiency project you are considering if possible and any carbon reduction target you have*

The trust is currently involved in discussions with a NHS Framework provider / supplier regarding a potential site wide energy efficiency project.

The Trust has previously taken part in the pilot Carbon Trust public sector (NHS) scheme.

- *Detail any major new electrical work you are considering including new building projects.*

The 2015/2016 capital schemes have not been finalised, we are therefore unable to provide details at this time.

There are currently no plans for any major new electrical work for 2015/201, however, we would tender any such works via the [nep.eu-supply](http://nep.eu-supply) website portal.
