We are now pleased to respond to your request for information under the Freedom of Information Act.

You asked:

With reference to FOI request 2325; could you please confirm when the project took place as that is a little unclear

The project was undertaken by an external company from Dec 12 until April 13 and was then rolled out by our own staff through 2013/14 as part of the Trust CIP target scheme

Question 7 asked for overrun prior to the project, during the project and after -- the answer simply states 44% which does not actually answer the question asked.

This data includes both elective and emergency theatre late finishes for each financial year from the orbit reporting portal for all sites and theatres:

1st April 2008 – 31st March 2009 : 44.4%

1st April 2009 – 31st March 2010 : 44.6%

1st April 2010 – 31st March 2011 : 45.0%

1st April 2011 – 31st March 2012 : 33.0%

1st April 2012 – 31st March 2013 : 33.5%

1st April 2013 – 31st March 2014: 34.0%

the number of elective operations in total performed prior to the project, during the project and after.
the number of elective operations performed on the standard theatre template prior to the project, during the project and after.*
