Refusal Notice: Section 41 - Information provided in confidence

Section 41 of the Act sets out an exemption from the right to know where the information requested was provided to the public authority in confidence. It has been confirmed by the Information Tribunal that the duty of confidentiality does continue after the death of an individual to whom that duty is owed. Where there is a legally enforceable duty of confidentiality owed to a living individual, after death it can be enforced by the deceased's personal representative. Every person on death has a personal representative and it will not be necessary to identify the individual who has this responsibility. This principle is of particular relevance to those public authorities holding records about an individual's personal details, such as health records, banking details or the provision of care.
