Hearing Aid Battery Safety

It is potentially dangerous for anyone to swallow a battery or poke one into their ears or nostrils.

If you suspect an individual has swallowed a battery, or put a battery in their nose or ear, they should be taken to the nearest Accident and Emergency (A&E) department as soon as possible.

Take the battery packaging with you if you can. This can help the hospital staff identify the type of battery and support any action that may need to be taken.

Try not to let young children see the batteries being changed. It is safer if young children do not know that the battery compartment opens. Your Audiologist can if required fit a child proof battery lock to the hearing aids.

Important: Even if your child's hearing aids have a tamperproof battery lock, you should never leave babies or young children alone with their hearing aids.

Hearing aids should be stored out of reach of children when not in use, remember that they are no longer tamperproof once the battery drawer is open.

When should hearing aids be tamper proof?

All babies and children aged 5 years or under should have tamper proof battery drawers on their hearing aids.

For older children and adults, the need for tamper proofing should be considered for:

- Those living with babies or children under 5 years of age
- Those with additional risk factors or living with those with additional risk factors such as health conditions or disabilities that might put them at risk of swallowing a coin or button battery, or pushing one in to an ear or nostril. This includes, but is not limited to, those with significant learning disability, dementia or other cognitive or sensory impairment.

How should I store and dispose of batteries?

New batteries should be kept in their original packaging, out of sight and out of reach of children. They are best kept in a sealed container in a high cupboard.

When a battery is flat, it is still a risk. The batteries should be put out of children's reach straight away and disposed of as quickly as possible. Batteries should not be put into the household rubbish, but put into special disposal containers.

Our Audiology clinic has recycling boxes to return used batteries and many supermarkets have battery disposal bins.

It is good practice to keep your used batteries in the original packaging so that you can keep them safe and make sure that no old batteries have gone missing.

Dispose of used batteries carefully. Batteries contain chemicals that could be harmful. Used batteries should be recycled. Our Audiology clinics have recycling boxes for used batteries.

Please note: Batteries are also a risk if ingested by animals, please take your animal to the vet as soon as possible if you suspect it has ingested a battery.

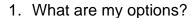
