With reference to your request for information received on 10th January 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

Please could you answer the following questions about acute kidney injury (AKI) care.

- 1. Does your trust have an AKI lead? (Yes/No) Yes.
- 2. Do you use an AKI bundle for patient care within your trust? (Yes/No) Yes.
 - a. If so what care bundle do you use? The Trust has a published Northwest Kidney AKI manual available on the intranet and use the fluids 24 bundle within our teaching.
- **3.** Are you a paperless trust? (Yes/No) No, but we are a paper light Trust.
- 4. What electronic system do you use for electronic noting? Altera Sunrise mainly. However, we also use SystmOne, Euroking, Badger and a couple of other minor systems that hold clinical notes.
- 5. Is your electronic noting system used for all healthcare professions within the organisation? (Yes/No)

Yes.

- 6. Do you have AKI nurses within your trust? (Yes/No) Yes.
 - a. If so how many? Are they clinical nurse specialists, advanced practitioners, or another role title?

The Trust has a part time Band 6 AKI Nurse in a split role with Sepsis. There is also a newly appointed Band 4 Nurse associate who has joined the team on an 18-month secondment.

- b. Does their role banding meet national standards (Qualified Advanced Clinical Practitioners 8a, Trainee Advanced Clinical Practitioners- band 7, Lead Clinical Nurse Specialists – band 7, Clinical Nurse Specialist- band 6)? (Yes/No) Yes.
- 7. Does your trust have a renal unit? (Yes/No)

No, we do not have a nephrology onsite at WWL. However, we have visiting consultants from Salford Royal Foundation Trust (SRFT) twice weekly.

8. How many adult inpatient beds does your trust have?
