With reference to your request for information received on 20th January 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

Please may you provide me with the answers to the following questions:

- 1. What are the total number of NHS referrals for primary inguinal, femoral, umbilical and epigastric hernia repairs at your trust in the last 3 years with a year-on-year breakdown? The Trust does not hold this information as referrals are not available at diagnosis or procedure level.
- 2. What are the total number of primary inguinal, femoral, umbilical and epigastric hernia repairs performed for the NHS at your trust in the last 3 years with a year-on-year breakdown?
