With reference to your request for information received on 4th February 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- Please could you state how many patients were treated by your Trust in the last financial year (23/24) who were patients that should have paid for their treatment because they were not entitled to free NHS hospital care?

- 2. How many of these patients who should have paid for their treatment had
 - a. elective treatment and

b. non-elective treatment

Elective and non-elective treatment is not recorded on the invoices. Therefore, The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

- 3. Of those patients who were billed for treatment how many were
 - a. for elective treatment and the bill is still wholly or partly outstanding and what is their cumulative value (the unpaid balance) in total and
 - b. how many were for non-elective treatment and the bill is still wholly or partly outstanding what is their cumulative value (the unpaid balance) in total? The information is not recorded to the detail of elective and non-elective treatment. However, 13 of these patients have an outstanding balance remaining, which is currently £94,206.26.

4. Please provide a nationality breakdown of the patients who have unpaid bills against them for treatment in 23/24 showing the number of patients from each country.

Please note the nationalities by patient count are being withheld under section 40(2) (personal information) of the Act. This is because releasing the nationalities would make individual patients identifiable. Section 40(2) is an 'absolute' exemption, and the Trust is not obliged to consider whether the public interest favours disclosing the information.

Section 40(2) exempts personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of the information would, amongst other things, contravene one of the data protection principles in Article 5 of the UK GDPR. In this case, I believe disclosure would contravene the first data protection principle, which provides that personal data must be processed fairly and lawfully.

However, the nationalities of these patients are American, Lithuania, Nigerian, Philippines, Thai and other patients whose nationalities were not known at the time of treatment.

5. Please state the amount of the largest unpaid bill for a chargeable patient for

- a. elective and
- b. non-elective treatment in the last financial year (2023/24), giving the amount that is due, the speciality or specialities involved in treating those patients, and the patients' country of residence.

The Trusts invoices do not record the speciality the patient was seen under nor their country of residence, therefore, The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

However, the largest outstanding bill of the 16 patients mentioned above is £15,344.87.
