With reference to your request for information received on 12th September 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. **How many of the following intra-vitreous injections/implants has your trust administered in the four-month period from May to August 2024:**
 - **Aflibercept** = 990.
 - **Bevacizumab – Avastin** = 16.
 - **Bevacizumab – Biosimilar** = 0.
 - **Brolucizumab** = 0.
 - **Dexamethasone** = 38.
 - **Faricimab** = 1,043.
 - **Fluocinolone acetonide** = <5.
 - **Ranibizumab - Lucentis (pre-filled syringes)** = 43.
 - **Ranibizumab - Lucentis (vials)** = 0.
 - **Ranibizumab – Ongavia** = 0.
 - **Ranibizumab – Ximluci** = 11.
