In your request you asked:

- 1. What system is currently used by the Trust for Theatre Management and Scheduling?**  
Operating Room Management Information System (ORMIS). However, the Trust are currently in the process of replacing this with the Altera Surgical Care solution, due to go live early 2025.
- 2. When does the contract for this system expire, and when is it due for renewal?**  
Ormis - 31/12/2024. Altera contract currently in renewal.
- 3. What system is currently used by the Trust for managing pre-operative assessments?**  
Altera Sunrise Clinical Manager.
- 4. When does the contract for this system expire, and when is it due for renewal?**  
Altera contract currently in renewal.
- 5. Are your patients able to complete a pre-operative questionnaire electronically at home? If so, which system facilitates this?**  
Yes, MyRecovery. This was rolled out to hip and knee arthroplasty for their initial screening assessment tool. The Trust plans to roll this out across all patients within the coming 12 months.
