With reference to your request for information received on 8th April 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I am seeking information relating to both your Patient Administration System (PAS) and your Electronic Patient Record (EPR), as outlined in the table below.

1. PAS

Costs from 2017 to present are £1,600,801.

- b. **The name of your current PAS supplier.**

- The contract is managed by the Deputy Director for Clinical Informatics.

- PAS System Administrator 2 WTE Band 5.

Altera, Allscripts and Trustmarque.

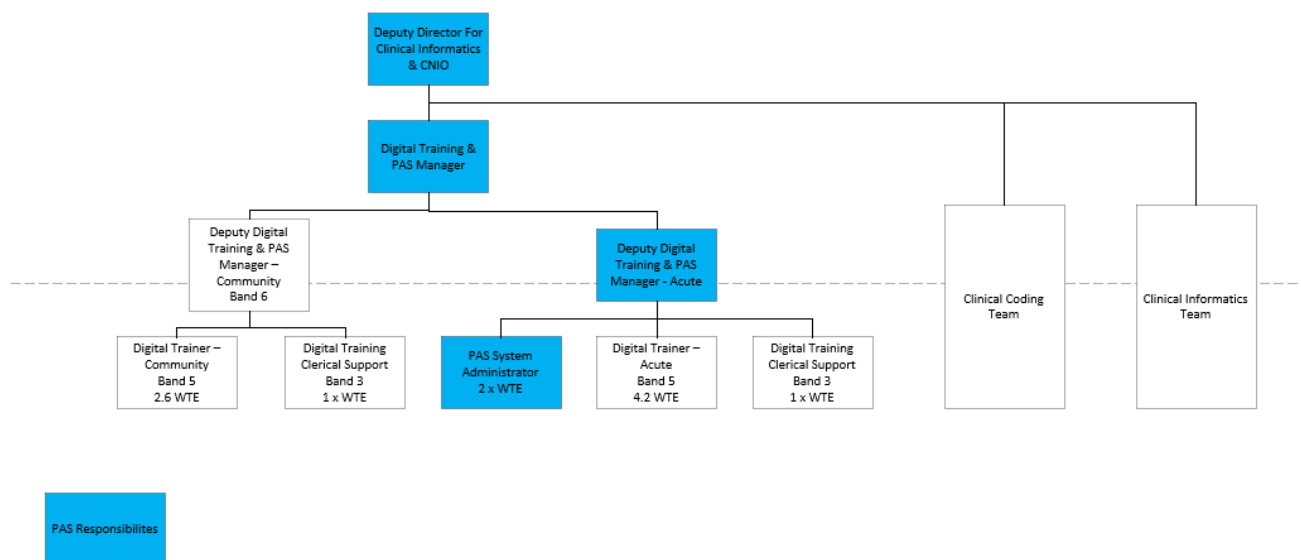
