Under Section 31 (1)(a) of the freedom of Information Act 2000, the information is exempt from disclosure where its disclosure would, or would be likely to, prejudice the prevention or detection of crime. The exemption is qualified by a public interest test. The trust believes that if it released the information requested into the public domain there would be a risk that this information could be used for fraudulent activities and disclosing the full registration may encourage vandalism or theft, all may place individuals at risk. Therefore, the trust considers that the balance of the public interest is in favour of withholding the information in view of the risk of crime.
