With reference to your request for information received on 15<sup>th</sup> July 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

**Under the Freedom of Information Act 2000, I am requesting a copy of your current policy relating to breastfeeding and/or expressing milk in the workplace for employees please.**

**If you do not have a standalone policy specifically covering breastfeeding/ expressing milk at work, I would be very grateful if you could please confirm this and provide any relevant sections from other policies (e.g. Maternity Policy, Flexible Working Policy, or Health and Wellbeing Policy) that cover these provisions.**

**Specifically, I am interested in detail regarding:**

- **Provisions for suitable breaks and facilities for expressing and storing milk.**
- **Support and adjustments available for employees who are breastfeeding or expressing milk upon their return to work.**
- **Information pertaining to breastfeeding risk assessments**
- **Any other relevant guidelines or policies addressing this matter.**

The Trust does not have a specific policy for breastfeeding/expressing at work and it doesn't form part of any of our other HR policies. Cases of breastfeeding and/or expressing at work would be accommodated at managers discretion to facilitate staff. We are in the process of developing a guidance document for our staff.
