 Please provide your total annual spend and total number of patients (for each of the last three financial years) on ADHD and Autism assessments, broken down by age categories as listed below.

Autism Assessments - Autism assessments under 18 years old, figures from the School Age ASC Pathway who accept referrals for children age 4-16. The service facilitates an assessment process coordinating the collection of information and referral for face-to-face assessments by other services, culminating in a multi-agency panel for diagnosis of Autism. Each patient who meets the criteria to go on for face-to-face assessments requires a minimum of two assessments from different clinicians/disciplines in order to be discussed at panel.

The Speech & Language Therapists sit within the division but not directly for the School Age Autism Pathway team. The other 0.3wte is the time each week for the pathway manager spent conducting ADOS assessments to alleviate long waits for social communication assessment within the division.
