With reference to your request for information received on 22nd July 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. Percentage of staff involved in direct patient care who are up to date with each of their routine immunisations as listed in the Chapter 12 of the Green Book
 - MMR
 - · Tetanus and diphtheria
 - Polio

The above are usually childhood vaccinations provided by GP practices, ours are occupational immunisations. Please redirect your questions to GM ICB at nhsqm.foi@nhs.net.

- 2. Uptake of the following vaccines by staff involved in direct patient care as listed in the Chapter 12 of the Green Book:
 - BCG (as per Green Book guidance) = Please see the Section 12 exemption below.
 - **Hepatitis B** = Please see the Section 12 exemption below.
 - Varicella = Please see the Section 12 exemption below.
 - Influenza = Please see the table below.

- The percentage of all staff listed in Chapter 12 of the Green Book who have received/are up to date with the vaccine
- The percentage of doctors who have received/are up to date with the vaccine
- The percentage of nurses and midwives who have received/are up to date with the vaccine
- The percentage of allied health professionals who have received/are up to date with the vaccine

The Trust is unable to provide this information for BCG, Hepatitis B and Varicella as the information is not held in a reportable or structured format in our central system and records would have to be reviewed manually which would exceed the appropriate time limit. The Trust has to take into account the cost attributable to the time spent in locating, retrieving, and collating the information. We have therefore applied exemption Section 12 (4) (b) of the Freedom of Information Act 2000-beyond appropriate limit. The appropriate limit is set at £450.00 (18hrs @ £25 per hour).
