With reference to your request for information received on 28th July 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I am writing to request the following information under the Freedom of Information Act:

1. The name and email address of your Clinical Safety Officer.

The Trust does not have a Clinical Safety Officer within Pharmacy, however there is a Medicines Safety Officer. This role is currently filled by Gary Masterman, Deputy Chief Pharmacist (Governance).
