With reference to your request for information received on 31st July 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. How many laparotomies were performed in the years 2024, 2023 and 2022 at Wrightington, Wigan and Leigh NHS Foundation trust.

Elective = The Trust codes surgeries using the national standard demonstrated below, therefore the actual surgery is coded rather than the approach incision, therefore this information is not centrally recorded, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

PGCS8: Incision as a means of approach

When incisions are made as a means of approach in order to perform further surgery on the site, the incision itself must not be coded.

Examples:

Laparotomy with excision of cyst of left ovary

Q43.2 Excision of lesion of ovary

Z94.3 Left sided operation
