With reference to your request for information received on 10th October 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I am writing to request information under the Freedom of Information Act 2000 regarding the procurement of uniforms and linen by your organisation.

Specifically, I would like to obtain the following details:

1. Current supplier(s) for uniforms and linen.

Uniforms = Work in Style, Slater Workwear, Alexandra Workwear and Arco. Linen = Synergy LMS.

2. Contract end date and any known renewal or retender schedule.

Uniform = No timeframe but undertaking for new uniform initiative ongoing with current main supplier on rolling in basis to stagger manufacture.

Linen = 12 months extension currently under review by WWL and GM Procurement Hub.

- 3. Annual usage in quantity (e.g., pieces or sets) for each product category tentative 2,419,164 pieces per annum.
- 4. Annual spend amount on uniforms and linen over the past 12 months.

Uniform and protective clothing = £109,554.

Linen = £1,033,398.

- 5. Any measurable social value commitments linked to the contract, such as local employment initiatives, skills development, or community benefits.

 None.
- 6. Any reported carbon reduction outcomes related to the supply or logistics of uniforms and linen.

None.

- 7. Any sustainability metrics tracked, including material composition, recycling/repurposing initiatives, or environmental impact assessments.
 - The suppliers would need to be compliant with the Trust's regulations, in line with the contract terms and conditions.
- 8. Whether SME suppliers are considered or encouraged for participation in future procurement exercises for uniforms and linen.
