With reference to your request for information received on 27th October 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. On how many days between 1 April 2024 and 30 September 2025 was your home birth service suspended or restricted (ie would not have attended a woman in labour at home if requested to do so)?

(ie were booked for a home birth and were then told they had to give birth in a hospital or birthing unit or contacted you during labour, asking for a home birth even if this had not been booked in advance) The Trust does not record this information
