With reference to your request for information received on 10th November 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. **Please provide the total number of patients treated in the last 6 months for:**
 - Polycythaemia Vera (ICD10 code D45) = 36.
 - Myelofibrosis (ICD10 code D47.4) = 12.
 - Myelofibrosis (ICD10 code D47.4) patients aged 65 and older= 12.
2. **How many patients were treated in the past 6 months (for any disease) with:**
 - Ruxolitinib = 10.
 - Fedratinib = 0.
 - Momelotinib = 4.
3. **How many patients were treated with Ruxolitinib in the past 6 months for the following diseases?**
 - Myelofibrosis (ICD10 code D47.4) = 8.
 - Polycythaemia Vera (ICD10 code D45) = 1.
 - Other/Unknown = 1.
4. **How many myelofibrosis (ICD10 code D47.4) patients has your trust diagnosed in the past 3 years?**

8 patients who started treatment for Myelofibrosis within the last 3 years.

 - **Of these patients, how many were treated in the past 6 months with Hydroxycarbamide?**
