#### **System definitions:**

**Ambient Voice Technology (scribing):** Ambient Voice Technology (AI Scribe) - Technology that automatically captures and transcribes clinician–patient conversations in real time and uses artificial intelligence to generate structured clinical notes or documentation. This differs from standard speech recognition or dictation tools because the system works in the background during consultations and produces draft notes for clinician review rather than requiring manual dictation.

**Blood tracking:** A system that electronically tracks and matches blood products with the correct patient (from fridge to vein).

**Clinical data warehouse:** A centralized repository for a healthcare organization's data retrieved from disparate sources, processed, and structured for analytical querying and reporting.

**Clinical Portal:** An electronic window that will allow clinicians to view defined information about individual patients in a 'virtual' electronic patient record drawn from information held in different clinical systems. Integrates a variety of products and services in the clinical setting.

**Health Information Exchange (HIE):** Is the electronic transmission of healthcare-related data among medical facilities, health information organizations, and government agencies according to national standards. HIE enables care professionals to view shared records and make more informed decisions for patients.

**Live operational dashboard system:** Live operational dashboard system-this is a toolset developed to provide clinicians with the relevant and timely information they need to support daily decision making that improve quality of patient care

**Oncology e-prescribing:** Module or functionality that supports electronic chemotherapy prescribing, medication administration and dispensing activities.

**Patient Portal:** It is a secure online website or app that allows patients to access their health records and perform basic transactions with their providers. The portal facilitates communication, appointment scheduling, bill payment, prescription requests and other administrative tasks.

**Pharmacy:** Pharmacy orders and stock control is managed electronically  
**Transfers of care system:** System used to manage and collect data on patient moving from one care provider to another.

**Virtual Wards:** Virtual wards, also known as virtual care wards or hospital-at-home programs, are healthcare models that aim to provide hospital-level care to patients in their own homes. These programmes typically utilise telehealth technologies and remote monitoring systems to deliver medical care and supervision to patients who would otherwise require hospitalisation.
