With reference to your request for information received on 12<sup>th</sup> November 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

The above is based on Violence and Aggression incidents reported on Datix.

**4. Please confirm what levels of conflict resolution conflict management Physical intervention Breakaway training (e.g., Level 1, 2, or 3) are provided to clinical staff. Do you have Security In house or Outside Agencies and the level of their Training**

All staff are required to complete the national conflict resolution training which is aligned to the CSTF and completed every 3 years.

The Security Services are an external contractor and are trained (externally) in MAYBO. MAYBO is a specialized training program focused on conflict management and personal safety, designed to help staff in various sectors manage challenging behaviour's and reduce risks. The security staff also receive Crisis Prevention Institute (CPI) Training provided in-house by our Safeguarding Team.

The Crisis Prevention Institute (CPI) is internationally accredited by IACET, RQF and CPD and is certified as meeting the Restraint Reduction Network Training. Safety Intervention included in CPI training includes break away training.

**5. Please indicate:**

- Whether this training is mandatory;**

The core skills training framework conflict resolution training is mandatory.

CPI Least Restrictive Training is not a mandatory requirement for staff, however it is strongly recommended as part of the Trusts Least Restrictive Action Plan. The Action Plan sets out the Trusts commitments to embedding Least Restrictive practice across all services, and includes the requirement that all clinical staff complete CPI training.

- The frequency/renewal period of the training (e.g., annually, every three years);**

The core skills training framework conflict resolution training, every 3 years.

It is a requirement of CPI that all staff who complete CPI Safety Intervention Foundation and Clinical Holding Training are required to undertake a 1-day annual update in order to maintain their accreditation and license.

- Whether this is in line with Trust policy and NHS England VPR standards.**

The core skills training framework conflict resolution training is in line with the current national standards.

Our current compliance for the national Conflict Resolution mandated training is 97.3%.

The Trust have been facilitating CPI Safety Intervention & Clinical Holding training since 2024 to date 801 staff hold an active accredited CPI licence

Yes, this meets our internal targets.

CPI training compliance is reported monthly divisionally via Safeguarding Operational group with executive oversight by the Safeguarding Effectiveness group

**8. Please confirm who delivers the conflict management and physical intervention training (e.g., Trust-employed security trainers, external providers, or clinical educators).**

The Trusts CPI trained facilitators have successfully completed the CPI Instructors Safety Interventions and Clinical Holding Facilitator Course. All trained facilitators are required to be reaccredited externally by CPI on an annual basis. MAYBO is delivered by OCS.
