With reference to your request for information received on 4th December 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold part of the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. **How many patients have been treated (for any condition) in the last 4 months with:**
 - **Benralizumab** = 56.
 - **Dupilumab** = 82.
 - **Omalizumab** = 22.
 - **Reslizumab** = 0.
 - **Mepolizumab** = 9.
 - **Tezepelumab** = 17.
2. **How many patients have been treated in the last 4 months by the Respiratory Medicine department ONLY with:**
 - **Dupilumab** = 2.
 - **Omalizumab** = 21.
3. **How many patients have been treated in the last 4 months for Chronic Obstructive Pulmonary Disease (COPD) with:**
 - **Dupilumab**
 - **Mepolizumab**

The Trusts pharmacy systems do not store indication data. Therefore, the Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

Relevant Period = July 2025 to October 2025 as this is the latest month with a complete data set.
