With reference to your request for information received on 9th December 2025, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

How many patients were treated in the last 6-month period with branded or generic emtricitabine / tenofovir disoproxil fumarate for Pre-exposure prophylaxis (PrEP)?	<5 patients were treated with the drug (all indications)
How many packs of branded or generic emtricitabine / tenofovir disoproxil fumarate were dispensed in latest 6-month period for HIV treatment?	<5 packs issued (all indications)
How many packs of branded or generic emtricitabine / tenofovir disoproxil fumarate were dispensed in latest 6-month period for Pre-exposure prophylaxis (PrEP)?	<5 packs issued (all indications)
How many patients were treated in the last 6-month period with tenofovir alafenamide / emtricitabine (Descovy) for HIV treatment?	0
How many patients were treated in the last 6-month period with tenofovir alafenamide / emtricitabine for Pre-exposure prophylaxis (PrEP)?	0

How many packs of tenofovir alafenamide / emtricitabine were dispensed in latest 6-month period for HIV treatment?	0
How many packs of tenofovir alafenamide / emtricitabine were dispensed in latest 6-month period for Pre-exposure prophylaxis (PrEP)?	0

We are withholding the exact figure under Section 40(2) of the Freedom of Information Act 2000, as disclosing it could lead to the identification of individuals. This constitutes personal data, and its release would breach the data protection principles.

Please note that the pharmacy systems do not keep indication data and so we are unable to determine whether the issues were for prevention or treatment. Although we aren't a HIV treatment centre, we do have patients admitted for other reasons whilst being treated for HIV so the data should not be used to assume this either way.
