Dear Sir,

With reference to your request for information received on 13th March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. The longest wait from an Urgent Suspected Cancer or Breast Symptomatic Referral, or Consultant Upgrade to a First Definitive Treatment for Cancer in the Trust in 2023/24 (so far)? The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes.
- 2. How many patients in your trust are currently waiting longer than 6 months (186 days) from an Urgent Suspected Cancer or Breast Symptomatic Referral, or Consultant Upgrade to a First Definitive Treatment for Cancer?

The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes.

The information requested is not centrally held by Wrightington, Wigan and Leigh Teaching Hospitals, a manual trawl of patient records would be required. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

However, it is worth noticing that the Trust often does not treat cancer patients depending on the treatment/tumour site. We investigate, diagnose, and refer onwards to other Trusts. However, still track the patient's pathway and get a share of the treatments compliance as this is how cancer performance operates.
