With reference to your request for information received on 20<sup>th</sup> March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

## 1. The number of data breach incidents recorded in the trust between 2021/22, 2022/23 and 2023date (March 2024).

Data breaches are categorised by Availability, Integrity, and Confidentiality. To determine if the breach falls within the scope provided of "any breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorised disclosure of, or access to, personal data" each incident would need to be individually reviewed. For example, a breach that has incorrectly stated a limb to be x rayed would not fall within the scope provided but would be categorised as an Integrity breach.

There are over 1000 breaches to be reviewed in each of the years provided, therefore we are unable to provide this information.

**Refusal Notice for question(s)** - The information that you have requested is exempt under Section 12 of the Freedom of Information Act because it will take more than 18 hours to retrieve and extract the relevant information.

12. - (1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

## 2. How much has the trust paid out in compensation for Data Breach claims between 2021/22, 2022/23 and 2023-date (March 2024)?

2021/22 = £53,150 2022/23 = £17,750 2024/24 = £10,275
