With reference to your request for information received on 26th March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. Can you please provide your spend for the last full available year (stating which one) on asbestos surveying and associated services (e.g. inspection, monitoring and testing, but excluding removal) £113.328.
- 2. Could you provide the number of buildings that you manage and the percentage of buildings containing asbestos?

111 buildings associated with the main Hospital Sites with 56% containing ACMs.

- 3. Could you please provide your spend on the following surveying areas for the last full available year (if no spend in the last full year, please provide the most recent year of spend):
- a. Fire assessments (e.g. Fire risk assessments, external fire wall surveys, compartmentation surveys if available)

Fire Risk Assessments (FRA) do not incur any additional costs as they are an integral part of the role of the Fire Safety Manager and Advisor.

b. EPC / DEC assessments £2.400.

Please state the number of properties that fall under this remit.
 16 certificates.

c. Stock condition surveys.

6 Facet Surveys 2023/24 ("Stock Condition Report")
Cost was £77,000 + vat to our 3 acute sites –
Leigh Infirmary
Royal Albert Edward Infirmary
Wrightington Hospital

d. Damp and mould surveys.

The Trust does not routinely undertake damp and mould surveys.

4. For each of the survey types, please provide the number of properties receiving the survey in the last full year

- Asbestos 111 buildings across 3 No off-hospital sites.
- Fire Risk Assessments etc External wall surveys are part of the 6-facet survey.
 Compartmentation surveys are completed at the pre-construction phase of any building work and upon request from our insurers.
- EPC / DEC 16 No off certificates / "properties".
- 6 Facet Surveys 3 No off-hospital sites.
- Damp & Mould Surveys not routinely undertaken therefore unable to state "properties".
