### **Refusal Notice: Sec 40(2) Personal Information**

The Trust has a policy of not releasing information when the data involved is less than 5. This is because we feel that such low numbers could make the individuals involved identifiable and therefore may cause undue harm and distress.

1 dose per exam but this may be administered as an infusion or as a stat bolus. Once contrast has been administered it cannot usually be administered again during the same examination.

### **4. The number of rescans, which are performed due to the outcome of a poor-quality image when using a macrocyclic gadolinium contrast agent in the initial scan.**

This data is not recorded.

**5. The number of rereports required due to the outcome of a poor-quality image when using a macrocyclic gadolinium contrast agent in the initial scan.**

This data is not recorded. However, please note all MR scans must be reported regardless of the diagnostic quality.
