With reference to your request for information received on 22nd November 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. The original Freedom of Information response issued on the 18th December 2023 contained inaccurate information; please accept our apologies and find the correct data below.

In your request you asked:

1.A What are mortality rates amongst mothers between 1 November 2021 to 1 November 2023?

2.A What are birth injury rates amongst mothers between 1 November 2021 to 1 November 2023?

First degree perineal laceration during delivery = 389 (equates to 7% of deliveries)

Second degree perineal laceration during delivery = 934 (equates to 18% of deliveries)

Third degree perineal laceration during delivery = 89 (equates to 1% of deliveries)

Fourth degree perineal laceration during delivery = 6 (equates to 0.1% of deliveries)

Pelvic floor muscle damage – The Trust does not record this information.

Pelvic organ prolapse (POP) – The Trust does not record this information.

Pelvic fractures (this can include the public bone, coccyx, or sacrum)

Fracture of sacrum - 0 Fracture of coccyx - 0 Fracture of pubis - 0

Caesarean wounds - <5

2.B How much compensation has the trust paid out in birth injury claims in the same period irrespective of when the claim was made?

Maternal and neonatal birth injury settlement within the given time period was £1,567,000.

The Trust has a policy of not releasing information when the data involved is less than 5. This is because we feel that such low numbers could make the individuals involved identifiable and therefore may cause undue harm and distress.

To disclose this information would:

- a) Contravene the Data Protection Act principles in that it would amount to unfair and possibly unlawful processing, as there was a legitimate expectation by the third parties that this information would remain confidential, and
- b) Disclosure may cause damage or distress to the individual(s) involved, and that damage or distress would be unwarranted (section 10 of the DPA).

If we do not hear from you within 40 days, we will assume that we have been able to accommodate your request under the Freedom of Information Act 2000.
