- 1. Does the Trust provide a Late Effects of Cancer service, which may variously (but not exclusively) be described as:
- a. Late Effects/LE Service, Radiotherapy Late Effects Service
- b. Pelvic, Pelvic Radiotherapy, Pelvic Radiation Disease/PRD Late Effects Service
- c. Gastrointestinal & Urological, Gastrointestinal Late Effects Services
- d. Gastrointestinal Consequences of Cancer service
- e. Urological Late Effects Service
- f. Radiation Cystitis clinic
- g. Complex Cancer Late Effects Rehabilitation
- h. etc

Late effects from treatment of cancer including radiotherapy, surgery and chemotherapy are managed through follow up clinics by the individual cancer teams. These are usually dedicated follow up clinics for cancer patients either with an oncologist, surgeon, or clinical nurse specialist. Patients are highlighted in clinics and supported, and sign posted, as necessary. The clinical nurse specialists will also educate patients prior to treatment on side effects and each patient has a key contact if they have any worries or concerns.
