## Dear Sir/Madam

With reference to your request for information received on 5<sup>th</sup> June 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

- 1. The number of elective theatre sessions in 2023-24 that were the first session of the day (ie morning session). 3,906
- 2. Of those first sessions in 2023-24, the number that started late (ie, where the trust has recorded a late start, or where the start time exceeded the scheduled start time by >15 minutes) 2,035.

\*In line with Model Hospital, any session that is more than 0 minutes passed the planned start time is recorded as a late start.

3. Please provide a breakdown of the reasons for the late starts detailed above, and the frequency of each reason. For example, if there were 100 late starts, please provide a breakdown of reasons and how often they occurred, so that they sum to that 100.
