With reference to your request for information received on 25th June 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. Please provide the trust's Month 12 provider financial return from 2023-24. Please provide the returns in full.

The Trust considers some of the information included in the Provider Financial Return to be commercially sensitive. In order to provide the information that would not be exempt under section 43 of the Freedom of information Act, the team would have to collate and extract the information from the original spreadsheet. The original spreadsheet was provided to the Trust by NHS England and is locked for editing; therefore, the team would have to manually input all data into a new spreadsheet. This would take the team over the 18 hours legal timeframe. Therefore, this information is exempt under Section 12 of the Freedom of Information Act.

Section 16 of FOIA states 16 - (1) It shall be the duty of a public authority to provide advice and assistance, so far as it would be reasonable to expect the authority to do so, to persons who propose to make, or have made, requests for information to it.

In accordance with section 16 the summarised version of the Provider Financial Return will be released to the public once it has been laid before parliament. The PFR will be published at the following link: https://www.wwl.nhs.uk/annual-report-and-accounts There is currently a delay in laying NHS Foundation Trust annual report and accounts before Parliament due to the General Election. 2. Please also provide the trust's provider financial return from month 1 2024-25. Please provide the returns in full.

There was no PFR exercise completed in Month 1 2024/25.
