With reference to your request for information received on 20th May 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

Based on data from the last financial year:

1. Please state what percentage of your total discharges from the Acute Medical Unit are discharged home/to usual place of residence without support.

The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

2. For those patients, what was the average length of stay in the Acute Medical Unit?

The Trust is unable to provide this data as it is not recorded centrally, if recorded it would be held within individual case notes. As case notes are for the care and treatment of patients, we do not request staff to interrogate them in order to collate the information required to respond to Freedom of Information requests.

The average length of stay for the Acute Medical Unit is 2.49 days. This is not specific to those discharged home/to usual place of residence without support.

3. Please state what percentage of all admitted patients from A&E waited more than 12 hours from decision to admit to actual admission (12hr+ trolley waits)

This information is being withheld under Section 44 of the Freedom of Information act. Please see below.

- 4. Please state what percentage of cancelled elective operations for non-clinical reasons were due to:
 - a. Unavailable ward beds
 - b. Unavailable surgeon
 - c. Unavailable anaesthetist
 - d. Unavailable theatre staff

Section 44 - Prohibitions on disclosure

Section 44(1)(a) of the FOIA provides that information is exempt information if its disclosure is prohibited by or under any enactment. This is commonly known as a statutory bar to disclosure. It is an absolute exemption and so there is no public interest test to apply.

This information is exempt under section 44 of the FOIA because it is considered that due to the forthcoming local election, it could affect public support for a particular party.
