- 1. Please provide the name of the incumbent supplier for the Radiology PACS solution at your trust and what is the current contractual end date?**  
Sectra – end date February 2032.
- 2. Please provide the name of the incumbent supplier for the Radiology RIS solution at your trust and what is the current contractual end date?**  
Megentus – end date March 2025.
- 3. Please provide the name of the incumbent supplier for the Radiology Vendor Neutral Archive (VNA) solution at your trust and what is the current contractual end date?**  
Sectra – end date February 2032.
- 4. Please provide the name of the incumbent supplier for the Digital Pathology solution at your trust and what is the current contractual end date?**  
The Trust does not manage the Pathology service or system as this is a shared service operated by Northern Care Alliance (NCA).
- 5. Please provide the name of the incumbent supplier for the Cardiology PACS solution at your trust and what is the current contractual end date?**  
McKesson – end date April 2025.
