With reference to your request for information received on 2<sup>nd</sup> May 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

1. **How many patients were treated in the last 3 months by the Dermatology department (for any medical condition) with the following biologic drugs:**
  - **Adalimumab – Humira** = 16
  - **Adalimumab Biosimilar** = 7
  - **Apremilast** = <5
  - **Bimekizumab** = 25
  - **Brodalumab** = 0
  - **Certolizumab** = <5
  - **Deucravacitinib** = 0
  - **Dimethyl fumarate** = <5
  - **Etanercept – Enbrel** = 0
  - **Etanercept Biosimilar** = 0
  - **Guselkumab** = 52
  - **Infliximab – Remicade** = 0
  - **Infliximab Biosimilar** = 0
  - **Ixekizumab** = <5
  - **Risankizumab** = 45
  - **Secukinumab** = 24
  - **Tildrakizumab** = <5
  - **Ustekinumab** = 21

**2. How many patients were treated in the last 3 months by the Dermatology department for HS (Hidradenitis Suppurativa) ONLY with the following:**

- **Adalimumab – Humira = 0**
- **Adalimumab Biosimilar = 0**
- **Bimekizumab = 0**
- **Certolizumab = 0**
- **Infliximab – Remicade = 0**
- **Infliximab Biosimilar = 0**
- **Secukinumab = 0**
- **Ustekinumab = 0**

The Trust has a policy of not releasing information when the data involved is less than 5. This is because we feel that such low numbers could make the individuals involved identifiable and therefore may cause undue harm and distress.

To disclose this information would:

a) Contravene the Data Protection Act principles in that it would amount to unfair and possibly unlawful processing, as there was a legitimate expectation by the third parties that this information would remain confidential, and

b) Disclosure may cause damage or distress to the individual(s) involved, and that damage or distress would be unwarranted (section 10 of the DPA).
