With reference to your request for information received on 9th May 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

2. What is the name of the Mobile Device Management (MDM) system you use?

This information is exempt under Section 31 of the FOI Act for the following reasons: The Trust like any organisation may be subject to cyber-attacks and, since it holds large amounts of sensitive, personal and confidential information, maintaining the security of this information is extremely important. Cyber-attacks, which may amount to criminal offences for example under the Computer Misuse Act 1990 or the Data Protection Act 1998, are rated as a Tier 1 threat by the UK Government.

3. Is your mobile device management system managed by an external contractor?

4. Who is the external contractor that manages your mobile device management system?

Managed in house.

5. How many corporate mobile phones (Apple, Android) do you have deployed?
