- 2. How many in person DSE workstation assessments are outstanding? None
- 3. How many have been outstanding for over 12 months? None
- **4.** Has everyone who works from home had a DSE workstation assessment carried out? All staff working from home should have completed a DSE workstation assessment in line with the Flexible Working (incorporating Agile Working) Policy.
- 5. Who has carried out the home DSE workstation assessments and what training have they been given to carry out this task? Face to face DSE Assessments for staff working at home have been completed by trained members of the Health and Safety Team. For all others, the DSE training and assessment is completed using an online externally hosted programme. The Trust's Flexible Working (incorporating Agile Working) Policy contains a comprehensive toolkit for the management of DSE for home workers.
- 6. How many DSE workstation assessors does the Trust have?

- 7. How much time is allocated to each assessor to carry out the assessment role? Each in-person assessment takes approximately 1 hour
- 8. Is there a record kept of the people who have had the workstation assessment training? Yes held on the externally hosted online programme
- **9. How often is update training carried out for these assessors?** Every 3-years
- 10. Who assesses the assessors to ensure that assessments being done are being done in a consistent manner?

Competency is checked at the point of DSE Assessor training.

- **11. Are consistency checks made across the Trust?** Health and Safety Team, who are externally trained DSE Assessors, periodically review assessments for consistency.
- **12. What DSE assessment is made for mobile workers?** An externally hosted online training and risk assessment programme is available for all staff identified as DSE Users.
- 13. Is the Trust aware of how many mobile workers there are? Can you confirm the number and the number who have had DSE assessments completed.
