You asked:

Can the trust confirm and provide information on the following:

1. The Trusts wayfinding strategy.

The Trust engages with local groups such as volunteers, Access and the Royal National Institute for the Blind (RNIB) and undergoes a Patient Led Assessment of the Care Environment (PLACE), reporting to NHSE highlighting accessibility and signage within the Trust Sites.

The Trust has also engaged with an external signage company to undertake a signage review of the main acute site regarding its directional signage currently in place.

The Trust utilises volunteers to attend sites that they are not familiar with as mystery shoppers, ensuring our patients receive a positive experience when visiting our sites for appointments and visiting.

The Trust has a 5-year contract with AccessAble (running from July 2022), which provides access information to online access guides. Patients / public can use this resource to find out about access about departments, wards and services across all our local hospital sites.
